I understand that my voluntary participation including but not limited to appearances in the Program may reveal or relate personal information, and I further understand that me appearance, depiction, and/or betrayal in connection with the Program and my actions displayed may result in exposure to public scrutiny and I freely and knowingly consent to such conduct and waive any action against Producer.
